## PURCHASING AT THE CAPTIVA VILLAS COMMON QUESTIONS ANSWERED

### What is a condominium hotel?

A condominium hotel is similar to and operates like any other hotel. The primary difference is that individuals own the guestrooms and suites in a condominium hotel.

Typically, condominiums, as opposed to condominium hotels, place certain restrictions on the ability of the owner to rent their unit to outside guests. In a condominium hotel; however, no such restriction exists.

While not all condominium hotels provide complete hotel services, the Pink Shell Beach Resort & Spa will have extensive facilities for both owner and guest usage. Such facilities will include swimming pools, restaurants and lounges, a health spa and exercise facility, conference and meeting facilities and other recreational facilities. Most of these facilities and amenities are owned by Boykin Management Company, which will be responsible for their maintenance and refurbishment. The individual unit owner bears no financial or other responsibility for these facilities and amenities.

### Is the Pink Shell Beach Resort & Spa a timeshare?

Pink Shell Beach Resort & Spa is **NOT** a timeshare. You will own the fee interest in the condominium real estate.

### Will my condominium villa be furnished when I purchase it?

Yes, your villa will be completely furnished with a superior furnishings package featuring quality decor and furniture. Your villa will also be equipped with appliances.

### Who is the typical buyer at Pink Shell Beach Resort & Spa?

The profile and motivation of the buyers in the Pink Shell Beach Resort & Spa varies. Many are owners of other condominiums in the area.
